
INFORMATION PURSUANT TO ARTICLE 13 OF LEGISLATIVE DECREE 30.06.2003, N. 196 ("CODE REGARDING THE PROTECTION OF PERSONAL DATA")

Pursuant to art. 13 of Legislative Decree 30.06.2003, n. 196, we inform you that your personal data that you have provided and that you will provide may be processed in accordance with the provisions of the above mentioned statute and confidentiality obligations, which our company complies with.

1 - The processing of personal data includes its collection, recording, organization, storage, handling, modification, selection, extraction, comparison, use, linkage, blocking, communication, dissemination, deletion and destruction, that is the combination of two or more operations.

The data provided will be used for the following purposes:

- fulfil customer data and statistics;
- storage of customer and/or supplier accounting;
- management of the customers (administration of customers, contract, shipping and invoices; verification of reliability and solvency, etc.)
- management of suppliers (administration of suppliers, contracts, shipping, etc.)
- management of credit;
- complying with obligations under the civil and tax laws and European legislation;
- sending advertising material for promotional activities.

2 - Your data will be processed using tools designed to guarantee safety and confidentiality and may involve the use of automated devices or be printed on papery supports.

A - Your personal data may be shared with:

- business network;
- law firms;
- accounting firms;
- debt collection agencies;
- bank institutions for the management of payments received and made;
- post offices or other delivery companies;
- maintenance/repair companies of IT devices;
- typolithographies or other printing companies;
- Public Authorities and Administrations for compliance with the law.

B - Your personal data are subject to anonymous aggregate distribution for statistical purposes.

We also inform you that, in regards of the aforementioned processes of personal data, you may exercise your rights indicated in **art. 7 of Italian legislative decree 30.06.2003 No. 196**, referring to the owner of the process. In particular, you will receive confirmation of the existence of your personal information and their disclosure in intelligible form, indication of the origin of personal data, the purposes and methods of processing, and the logic and purposes which the processing is based on and the persons or categories of persons to whom the information may be disclosed. You may also receive updates, rectification or integration of data, deletion, transformation in anonymous form or obtain the blocking of data, handled in violation of the law or you may even oppose, for legitimate reasons to the processing of your personal data, of sending advertising material, carrying out market research or commercial or promotional activities

Providing data is optional, unless it is not required by specific standards. In this event, we remind you that any refusal to provide your personal data may conclude the contract or obstruct its proper process.
